MINUTES:

REPORTS:

Rules and Regulations Committee:

It was advised that the Rules and Regulations Committee will meet following this public hearing, and the other Planning Commission members were invited to attend.

DIRECTOR'S REPORT:

Mr. Gardner advised that the INCOG budget was presented to the County and the executive committee of INCOG and was approved and then sent to the full Board. It has been presented to the City, and we are now awaiting the final judgements on how much money they will award the agency.

SUBDIVISIONS:

Preliminary Plats:

Century Tower (1283) 74th Place and South Memorial Drive (CS, RM-T)

Oak Forest (2790) West 41st Place and South 128th West Avenue (RE)

Mr. Beckstrom advised the Commission that these two items need to be withdrawn from the agenda at this time. Without objection, the Chair, withdrew consideration of the Preliminary Plats for Century Tower and Oak Forest.

Waiver of Plat:

Z-5609 O. T. Dawson (2703) SE corner of East Tecumseh Avenue and North Kingston Place

This is a request to waive plat on the North 85' of Lots 2, 3, 4, and 5 of Block 16, Original Town of DAWSON. Since the property is already platted, improvements are in place and the applicant is only adding to an existing building. The Staff sees no objection to a waiver of plat. This small tract was surrounded entirely by CH zoning, and Z-5609 brought the remainder into the CH District for several blocks along Tecumseh and the railroad tracks. Recommend approval.
