Cutoff dates for PUD Minor Amendments will be 21 days prior to the TMAPC meeting at which the amendment will be considered. Cutoff dates for PUD Detail Site Plans and Alternative Compliance proposals for landscape plans are 14 days prior to the TMAPC meeting at which the plans will be considered.
